Procedures for Receiving Donations

- All donations must be accompanied by a Statement of Donated Funds.
- All donations must be approved by the ALL Foundation Board of Directors, including any specified use or purpose, in the case of Specific/Flow-Through Donations.
- All Specific/Flow-Through Donations shall be implemented by the Savannah Chatham County Public School System, consistent with internal policies and governing law. SCCPSS will submit any final costs to the ALL Foundation Board for final approval before beginning any work or incurring any expense. Upon completion of the work, SCCPSS will submit a final invoice showing the amount due and completion of work to the ALL Foundation Board. Upon approval by the Board, ALL Foundation will reimburse SCCPSS for the amount due.
- Donors will receive a taxable donation letter confirming receipt of the donation and amount potentially eligible for charitable deduction for tax purposes.
